Important!

Snow Removal Policy: Snow removal on private property is the responsibility of the landowner. Any requests for snow removal will be considered custom work and shall be applicable to the current rates with a minimum one hour charge. RM roads are first priority and no custom work requests shall be considered until such time that the operator(s) have the appropriate resources, including time, to do so. **For more information please contact the Municipal office or refer to the policy on the website.**

False Alarms: Should the Fire Department be dispatched to your property for a false alarm, charges are as follows

\$250 for first

\$500 for second

Actual cost incurred thereafter.
