
BYLAW NO. 2-2020

A Bylaw to amend Bylaw No. 5-2016, known as the Zoning Bylaw of the Rural Municipality of North Battleford No. 437.


The Council of the Rural Municipality of North Battleford No. 437, in the Province of Saskatchewan, enacts to amend Bylaw No. 5-2016 as follows:

- 1. Part 2 INTERPRETATION is amended by adding the following new definition immediately following the definition for "Bed and Breakfast Home":
 - "Bin yard: a site used for the storage of grain, fertilizer, machinery and other equipment."
- 2. Part 2 INTERPRETATION is amended by deleting the definition for "Agricultural Related Commercial and Industrial Uses; includes" in its entirety and replacing it with the following new definition:
 - "Agricultural Support Services: includes,
 - (a) grain and seed storage, cleaning and drying;
 - (b) fertilizing mixing sales (subject to provincial regulations);
 - (c) livestock and poultry breeding services;
 - (d) abattoirs;
 - (e) bin yards, and;
 - (f) other agriculturally related services."
- 3. Table 6-1: A Agriculture District Development Standards is amended by adding the Use "Agricultural Support Services" with the following development standards:




