
## BYLAW No. 4-2024


### A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR THE FURNISHING OF FIRE FIGHTING SERVICES AND EQUIPMENT

The Council of the Rural Municipality of North Battleford No. 437, in the Province of Saskatchewan, enacts as follows:


1. The Rural Municipality of North Battleford No. 437 is hereby authorized to enter into agreements that are attached hereto and forming part of this bylaw identified as EXHIBIT A with:
  - Village of Borden
2. The Reeve and Administrator of the Rural Municipality of North Battleford No. 437 are hereby authorized to sign and execute the attached agreement identified as EXHIBIT A

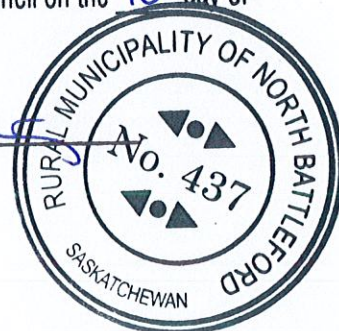

Agreement

Bylaw No. 4-2024

Memorandum of Agreement made this 4 day of July, 2024

The Village of Borden and the RM of North Battleford No. 437

1. Now therefore this agreement witnessed that in consideration of the covenants, terms and conditions hereinafter set out the aforementioned parties hereby agree to the following:
  - a. The RM of North Battleford No. 437 agrees to provide fire protection and emergency services, as hereinafter set out, to the Village of Borden.
  - b. The Village of Borden agrees to provide fire protection and emergency services, as hereinafter set out, to the RM of North Battleford No. 437.
  - c. The municipalities in this agreement guarantee that the departments providing fire protection and emergency services within the corporate boundaries of other municipalities agrees to pay for that service when provided.
  - d. Both parties agree that:
    - i. Each will set their own fees to be charged for providing fire protection and emergency services, set out in Schedule "A".
    - ii. Fees for fire suppression and rescue/extrication services provided as a result of an accident involving a motor vehicle or for loss of a motor vehicle will be as per SGI rates and charged to SGI directly.
    - iii. In the case of simultaneous fires, each will be responsible for the fire within their own corporate boundaries.
    - iv. Each will be responsible for their own insurance coverage.
    - v. Each will be responsible for their own equipment even when providing fire protection and emergency services in the municipality.
    - vi. Each agrees to invoice their own individual ratepayers for services received from the other fire department.
  
2. It is understood and agreed that this agreement shall commence on July 10, 2024 and will be continuous; either party may terminate the contract with seven days written notice.
