## **RURAL MUNICIPALITY OF NORTH BATTLEFORD NO. 437**

## **BYLAW NO. 5-2025**

A Bylaw to amend Bylaw No. 5-2016, known as the Zoning Bylaw of the Rural Municipality of North Battleford No. 437.

The Council of the Rural Municipality of North Battleford No. 437, in the Province of Saskatchewan, enacts to amend Bylaw No. 5-2016 as follows:

- 1. **Section 2 INTERPRETATION** is amended by adding the following new definition between the definitions of "Service Station" and "Site Triangle":
  - "Shopping Centre: a building or group of buildings, located on the same site and managed as a single unit, in which individual spaces are leased to permitted or discretionary commercial uses for their mutual benefit, including the use of off-street parking and other joint facilities."
- 2. Table 6-7: C1 Commercial and Light Industrial District Development Standards is amended by adding the following new use and associated development standards:
